## **1. INTRODUCTION/ACCEPTANCE OF TERMS**

Welcome to [www.iss.edu](http://www.iss.edu) ("ISS Site" or "Site"), a website provided to you ("User") by International Schools Services, Inc. ("ISS"), a non-for-profit leader in international school services which include an array of diversified and comprehensive services ("ISS Services") such as:

- Educational staffing and recruitment;
- School management, board governance, and risk management services;
- Procurement of international school supplies;
- World Language Initiatives;
- International Schools Directory; and
- Other Services that help position schools around the globe for success.

These Terms and Conditions of Service ("Terms") govern your use of this Site and ISS web-accessed services (description provided in section below). **BY USING THIS SITE, YOU AGREE TO THESE TERMS AND CONDITIONS OF SERVICE; IF YOU DO NOT AGREE, DO NOT USE THIS SITE.**

You should carefully read these Terms which include **ISS Privacy Policy** (provided on this Site) by reference before using the Site or ISS web-accessed services. ISS reserves the right, at its sole discretion, to change, modify, add or remove portions of these Terms at any time by posting an updated version to this Web page. It is your responsibility to check these Terms periodically for changes. Your continued use of the Site following the posting of changes will mean that you accept and agree to the changes. As long as you comply with these Terms, ISS grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the Site. Users who violate these Terms may have their access and use of ISS website suspended or terminated, at ISS's discretion.

In addition, when using particular ISS owned or operated services (e.g., Candidate Application Services, (i.e., for job seekers), or Employer Recruitment Services (i.e., for employers)), you and ISS may be subject to **additional terms of conditions/agreements, requirements, or guidelines applicable to such services**. In addition, you must provide and are responsible for all equipment necessary to access the ISS Services.
